Re: Hampden Residential Property #1

Your proposal has been reviewed by an interdepartmental environmental assessment screening committee and an opportunity to comment has been provided to the public as required by Part X of the Newfoundland and Labrador Environmental Protection Act, SNL 2002, cE-14.2. Please be advised that this undertaking is **released** from further environmental assessment subject to the following conditions:

- You must maintain a 30-metre naturally vegetated buffer along all waterbodies and wetlands to protect sensitive riparian and aquatic species and their habitat.
- No vegetation clearing is to occur within 800 metres of a bald eagle or osprey nest during the nesting season (March 15 to July 31) and 200 metres during the remainder of the year. The 200 metre buffer also applies to all other raptor nests (e.g. Northern Goshawk, Sharp-shinned Hawk, Merlin, American Kestrel, Great-horned Owl, Boreal Owl, Northern Saw-whet Owl). The location of any raptor nest site must be reported to the Wildlife Division of the Department of Fisheries and Land Resources at (709)637-2025.

The Department of Fisheries and Land Resources advises that Crown lands approval is required for Application No. 152317. Contact the Western Regional Lands Office at (709)637-2392. A domestic cutting permit is required prior to any harvesting or timber removal and an operating permit is required prior to the start of any work during the forest fire season. Contact the Forestry Pasadena District Office at (709)686-2071.

The Department of Service NL advises that plans and specifications of a sewage disposal system and water supply must be submitted to Service NL for evaluation before a Certificate of Approval can be issued. Contact Service NL at (709)637-2204.

The Local Governance and Planning Division of the Department of Municipal Affairs and Environment advises that you are to submit a development application to the Town of Hampden for Council's review and decision.

Environment and Climate Change Canada recommends that in order to avoid nest destruction and to accommodate the breeding season of migratory songbirds and waterfowl, operations should consider nesting locations between April 15th and August 15th in this region. However, as some species protected under the Migratory Birds Convention Act (MBCA) do nest outside of this time period, it is the responsibility of the proponent to ensure that project activities are in compliance with the MBCA and associated regulations. Although the undertaking, as proposed, is released from further environmental assessment, it is still subject to other legislative requirements. A summary of the comments received from government agencies during the review is attached to provide an indication of likely applicable permits, approvals and legislative requirements. Please note that you must comply with all relevant legislation and obtain all necessary permits and approvals. You are required to inform this Department of any proposed significant changes to the undertaking.
