The Honourable Bernard Davis, Minister of Environment and Climate Change, has announced the following relative to Part 10 Environmental Assessment of the **Environmental Protection Act**.

UNDERTAKING REGISTERED:

Burgeo Rifle Range Site Remediation Proponent: Department of National Defence

(Reg. 2283)

The Proponent is proposing to decommission and remediate the former small arms rifle range site located off route 480 in Burgeo. Project activities include soil excavation and sediment dredging and disposal, on-site impacted surface water treatment, and removal of debris. The undertaking was registered on December 21, 2023; the deadline for public comment is January 26, 2024; and the minister's decision is due by February 4, 2024.
