THE UNDERTAKING:

(i) Name of the Undertaking:

outfitter lodge spike camp- Long Harbour River Crown land application # 156669 file ref # 200.20.2988 and proposed trail

(ii) Purpose/Rationale/Need for the Undertaking:

To build a hunting lodge and associated trail for the purpose of non-resident hunting as an outfitter.

## **DESCRIPTION OF THE UNDERTAKING:**

(i) Geographical Location:

This site is located 50 m from Long Harbour River latitude 47.9152 longitude 54.8991. It would be located to the left of the hydro line if you travel from top of mile hill, just past Swift Current on the Burin Peninsula, heading on the hydro line going towards Bay d'Espoir before crossing Long Harbour River. Map 1 attached.

Description of proposed trail system is also attached proposed trail 1

### (ii) Physical Features:

Buildings will be wood frame construction consisting of main lodge facility 24feet x 48 feet, out building 10 feet by 14 feet woodshed, out building 10 feet x 12 feet generator house. Storage shed 16x24. There would be a pit privy also 4x4.

Area affected by this would be approx. .4 of a Hectare or under an acre. Drawing plan concept attached.

Area consist of a higher dry piece of land consistent with hard ground mineral soil in location. Vegetation is mostly black spruce and Juniper with ground cover mostly moss and lichens. Long Harbour River is a salmon river but there is a falls further down river and salmon do not reach the area of the river where we are located. We are building this lodge to hunt

Woodland Caribou at Present based on our allocation for Middle ridge Caribou management area 64. We were sent out to all Departments of Government 9 in all and we await the registering of this undertaking to start construction. The trial pics are included to show location on maps also. Short trail from hydro line. Drawings of trail is attached.

(iii) Construction (if applicable):

We were hoping to have this lodge built and open for 2020 Fall season as it is required and needed by our business through tourism department. As soon as we have application approved for lodge location through crown lands, we will submit the trail application which we already had reviewed by FLR and we submitted to you also. We will send the copy of the proposed trail also with this application. It may very well not get done this year having us to snowmobile materials in winter. We can use Hydro line to move materials close to Building site. Include information regarding proposed trails if they are included with this undertaking) We were hoping that we would have started by June 30<sup>th</sup>, 2020 and are still trying for late July early August. Our goal was to be open this fall. Construction is based upon approval of project and set to begin in Summer 2020.

We would be using generators for power and would have gas to operate on site or diesel for generators in approved containers, oil for generator. Possible gas and chain oil for chainsaws. All to be kept locked up. We are using pit privy, and garbage will be taken from location as needed and we will recycle what we can as we always do.

We do not see any resource conflicts here as we are not close to any other tourism hunting allocations and there is no mining or forestry operations here as we are close to Bay Du Norde wilderness area also. We are not encroaching on any buffer zones. Trail will run along forested land and trails maintained and upkeep with codroyed wooden sticks over any wet areas. There is only one small section that may require this as indicated on the maps. This is mostly dry barren. We do not see in environmental effects from construction.

## (iv) Operation:

This operation will operate at present as a spike location for lodge to hunt woodland caribou from September to December each year. If Moose allocation and bear allocation become available in future it will also be used at the same time for this, and May and June for Spring Bear. Day to day operation is 1 on one guiding with clients walking and hunting from parts of hydro line in caribou management area 64 Middle Ridge. Moose management area 26 Jubilee lake. Meals are provided at lodge and sleeping accommodations. Retrieving of meat from animals will be done with Argos and atvs where permitted to do so under current regulations and will be carried out by guides or float plane or helicopter where travel is not permitted inside wilderness area. Access to camp for clients will be helicopter or argo and atv via hydro line access.

# (v) Occupations:

This Project will employ 2-4 people in construction phase for a period of 60-120 days or longer if required.

There would only be owner operator there with journeyman carpenter and labours. Classed as 7271 carpenter and 7611 labourers.

All construction will likely be direct hiring of current staff.

All current staff that are available and qualified.no extra people required.

#### Good morning,

The federal environmental assessment process is set out in the <u>Impact Assessment Act</u> (IAA). The <u>Physical Activities Regulations</u> (the Regulations) under IAA set out a list of physical activities considered to be "designated projects." For designated projects listed in the Regulations, the proponent must provide the Agency with an Initial Description of a Designated Project that includes information prescribed by applicable regulations (<u>Information and Management of Time Limits Regulations</u>).

Should the Agency receive a request for a project to be designated, the Agency would contact the proponent with further information.

The proposed project may be subject to sections 82-91 of IAA. Section 82 requires that, for any project occurring on federal lands, the federal authority responsible for administering those lands or for exercising any power to enable the project to proceed must make a determination regarding the significance of environmental effects of the project. The Agency is not involved in this process; it is the responsibility of the federal authority to make and document this determination.








# **Proposed Trail From Hydro Line**


