Section 3: Scientific Research	

In accordance with the *Wilderness and Ecological Reserves Act* and pursuant regulations and policies, scientific research shall not occur within a reserve unless specifically authorized in writing by means of a Scientific Research Permit. Conditions may apply. Research applications for seabird ecological reserves must be submitted by March 31 in order to be reviewed by the Seabird Ecological Reserve Advisory Committee in April.

The following information must be provided and attached to the application form. Applications not including this information will not be processed.

- 1. Title of the proposed study.
- 2. Objective(s) of the proposed study.
- 3. Detailed description of the proposed methodology, including background information on proposed subject under study, and full disclosure of any proposed removal or displacement of materials (plants, insects, animals, sand, etc.).
- 4. Expected duration of the proposed study, including start and end dates of both field work and final analysis.
- 5. Names, positions, affiliations and professional/technical qualifications of all individuals involved in the proposed study.
- 6. Any other permits required (e.g. Canadian Wildlife Service, Animal Care, Wildlife Division).

## Section 4: Commercial Operator

In accordance with the *Wilderness and Ecological Reserves Act*, and pursuant regulations and policies, commercial operators (such as professional photographers, film crews, or tour operators) require a permit to conduct business in wilderness and ecological reserves. Conditions may apply. Commercial applications for seabird ecological reserves must be submitted by March 31 in order to be reviewed by the Seabird Ecological Reserve Advisory Committee in April.

The following information must be provided and attached to the application form. Applications not including this information will not be processed.

- 1. A short description of the proposed commercial activity, including purpose of venture, mode of travel, travel routes, equipment required, activity season, etc.
- 2. Demonstrate familiarity with the purpose of the reserve and the applicable regulations and policies.
- 3. Describe the professional/technical qualifications of all individuals involved in the operation.

#### Section 5: Educational Tour

In accordance with the *Wilderness and Ecological Reserves Act*, and pursuant regulations and policies, educational groups (such as schools or non-commercial organizations or groups) require a permit to tour wilderness and ecological reserves. Conditions may apply.

The following information must be provided and attached to the application form. Applications not including this information will not be processed.

- 1. Purpose of visit.
- 2. The dates of the proposed tour and number of people in the group.
- 3. Describe the mode of transportation and route.

#### Section 6: Seabird Reserve Access

In accordance with the *Wilderness and Ecological Reserves Act*, and pursuant regulations and policies, access to the sensitive nesting areas of seabird ecological reserves is restricted to individuals with a permit from the Land Management Division. The number of permits available is limited and applications are processed on a first come first serve basis. All visitors must be accompanied by a Seabird Ecological Reserve Guide. Conditions may apply. Access permits are only available for Baccalieu Island and Lawn Bay Seabird Ecological Reserves.

The following information must be provided and attached to the application form. Applications not including this information will not be processed.

- 1. Purpose of visit.
- 2. Detailed description of the project, including mode of travel and equipment to be used.
- 3. Names, positions, affiliations and professional/technical qualifications of all individuals involved in the project.
- 4. Proposed landing date/s, duration of visit, and number in party (including guide).
- 5. Any other permits required (e.g. Canadian Wildlife Service).
