Vendor Terms & Conditions **Domestic Category**

- 1. For the purpose of this licence the *Environmental Protection Act SNL 2002 cE-1*. and the *Pesticides Control Regulations*, 2012, shall apply.
- 2. The handling of all pest control products (pesticides) shall be conducted in strict compliance with the product label registered under the authority of the *Pest Control Products Act* (Canada).
- 3. The vendor shall ensure that all pesticides are stored and displayed in a manner that prevents environmental contamination or the impairment of the health and safety of any person:
 - a. Pesticides shall be stored in a manner as to contain any leakage;
 - b. All display units shall be constructed of a non-absorbent material that can be easily cleaned; and
 - c. All pesticides stored or displayed outdoors shall be protected from wind, rain and other weather hazards.
- 4. Pesticides in unsealed or damaged packages or containers shall not be placed on display under any circumstance, but shall be disposed of in accordance with the manufacturer's recommendations
- 5. In case of a pesticide spill/leak, the vendor shall ensure that:

- a. The product is quickly contained and clean up of the pesticide occurs immediately;
- b. Staff wear the proper protective clothing while cleaning up the spill/leak; and
- c. Any damaged packages or containers are disposed of in accordance with the manufacturer's recommendations.
- 6. The vendor shall ensure that groceries / food / beverages and personal use items are not subject to pesticide contamination:
 - a. Pesticides shall be stored or displayed at least 8 meters away from items listed above; and
 - b. Pesticides shall not be stored above food or drink or personal use items;
- 7. Pesticides shall not be stored above animal food or items intended for animal use or consumption.
- 8. The vendor shall ensure that seeds, fertilizers and soils that are intended for food production are not subject to pesticide contamination:
 - a. Pesticides shall be stored at least 2 meters away from these items; and
 - b. Pesticides shall not be stored above these items.
- 9. The vendor shall ensure that all rodenticides and liquid pesticides are stored or displayed at a minimum height of 1 meter above the floor.
- 10. The vendor shall ensure that there are no floor drains in areas where pesticides are to be stored or displayed.
- 11. Pesticide products for use on pets:
 - a. May be displayed next to animal feed, if separated by non-continuous shelving or by a solid, non-porous barrier which prevents the horizontal flow of material; and
 - b. May be displayed next to animal use items.
- 12. After January 1, 2010, a vendor who is required to have a certified domestic pesticide vendor on staff must place a sign in the pesticide display area, indicating that there is a certified domestic pesticide vendor available to answer any questions with regards to pesticides.

13. The vendor shall provide the annual (calendar year) sales figures of all pesticides sold from each location to the Pesticides Control Section by February 28th of the following year.
