Message from the Clerk of the Executive Council to Public Service Employees on COVID-19 Response

This is to acknowledge and express my gratitude to you, our valued employees as we continue to work our way through the COVID-19 pandemic. Whether you have been required to provide critical services in person or virtually or if you are at home awaiting information on potential deployment, the uncertain and disruptive impacts of this pandemic have been, and continue to be very trying for all of us.

Your cooperation and ability to adapt so quickly to our modified ways of working and delivering critical programs and services to the residents of Newfoundland and Labrador is truly appreciated.

As has been our experience over the last 10 days or so, service delivery decisions are continuously evolving as we refine and sharpen our plans. Your health and safety is paramount through every decision. To this end, we are working extremely hard to support employees with work from home arrangements. The Office of the Chief Information Officer (OCIO) is continuously working to expand remote access where needed and we are reallocating equipment to those working in our high priority areas.

Departments with public facing services, especially counter services have enacted process changes aimed at further reducing the level of face-to-face interaction in an effort to reduce the spread of COVID-19. These changes are reflected in Provincial Government news releases and public advisories which can be found here. This page is being updated regularly.

We are currently operating with the minimum number of employees to continue to provide essential services and programs. Going forward and until we see our way through to the end of this pandemic, work arrangements are as follows:

- Employees who will continue to deliver critical programs and services as well as all others who can work from home have been made aware of same and provided with direction on how they will continue their work safely;
- All other employees should stay home and remain available for possible deployment, if required.

I recognize this has been a time of great uncertainty for employees. It is likely that inaccurate information will be circulated; therefore, I encourage you to seek and rely on factual information as communicated by your employer. As we continue to work through this pandemic, it is likely that privacy issues may arise.
