Departmental Overview

The Intergovernmental and Indigenous Affairs Secretariat supports the Premier and ministers in building relationships with other sovereign governments and international entities to advance the province's interests.

The Secretariat also supports the Premier and ministers in building principle-based relationships with Indigenous peoples.

Organizational Structure

The Secretariat has two branches: Intergovernmental Affairs and Indigenous Affairs

Intergovernmental Affairs Branch

The branch has three divisions: Resource and Fiscal Policy, Social and Economic Policy, and Trade Policy.

The Resource and Fiscal Policy division formulates intergovernmental policy advice relating to the Provincial Government's resource, fiscal, and constitutional priorities, and supports First Ministers' intergovernmental priorities.

The Social and Economic Policy division formulates intergovernmental policy advice relating to social and economic policy priorities, as well as national defence and foreign affairs; and serves as government's military liaison.

The Trade Policy division leads the formulation of policy advice and consultative services related to national and international trade, including the negotiation and implementation of trade agreements.

Indigenous Affairs Branch

The Indigenous Affairs branch has two divisions: Policy and Planning, and Negotiations.

Through a respectful, principles-based relationship with Indigenous people, communities, governments and organizations, Policy and Planning supports government policies, programs and services that are culturally sensitive, meaningful and appropriate.

Policy and Planning is also responsible for the Indigenous consultation policies and practices to ensure Government discharges the Duty to Consult whenever it may arise.

Negotiations focus on the negotiation and implementation of land claims, self-government, and other agreements to promote the self-sufficiency, self-government, and cultural autonomy of Indigenous peoples, and to provide clarity with respect to the ownership and management of lands and resources in Newfoundland and Labrador.

As of March 31, 2019, the Secretariat had a staff complement of 23 (12 female and 11 male) and a budget of approximately \$3,692,217.

The Intergovernmental Affairs branch is located on the seventh floor of Confederation Complex, East Block, in St. John's. The Indigenous Affairs branch is located on the sixth floor.

Highlights and Partnerships

2005 Atlantic Accord Review

The Secretariat, in collaboration with the departments of Finance, Natural Resources, and Justice and Public Safety, led and concluded a joint federal-Provincial review of the Atlantic Accord in 2018-19, culminating in an agreement ensuring Newfoundlanders and Labradorians are the principal beneficiaries of their offshore resources, while strengthening the joint management of those resources. The agreement includes:

- A new and guaranteed revenue stream that will deliver \$2.5 billion to the province.
- This revenue stream immediately reduced the Provincial net debt by \$2.5 billion, or by approximately \$5,000 for every Newfoundlander and Labradorian. In total, the Provincial net debt decreased by 16 per cent, and savings on interest will be worth approximately \$100 million by 2056.
- Cash installments starting in 2019-20 until 2056, with no restrictions on the use of the funds, with approximately \$1.9 billion, or 60 per cent, being received by 2030.
- The revenue stream is from the Federal Government's equity interest in the Hibernia project; and
- A joint Federal-Provincial commitment to strengthen the joint management of Newfoundland and Labrador's offshore development in areas such as land tenure, worker safety, regulatory efficiency, and regulator modernization.

Through this agreement, Newfoundland and Labrador will continue to receive 100 per cent of its offshore resource revenues as if these resources were on land. The agreement also included a federal commitment to further engage with Newfoundland and Labrador to expeditiously examine the financial structure of the Muskrat Falls Project, so that the province can achieve rate mitigation.

Trade

In 2018-19, the Secretariat, in collaboration with departments across Government, led the Province's defense against the 2017 United States Department of Commerce's antidumping and countervailing duty (AD/CVD) investigation into uncoated groundwood paper (newsprint) exports from Canada. The Department of Commerce argued that Canadian newsprint exports were injuring the U.S. domestic newsprint industry. The investigation implicated Corner Brook Pulp and Paper and the Provincial Government, among other companies and provinces. The Secretariat, in collaboration with departments across Government, led the Province's defense in the investigation. While interim tariffs of up to 36 per cent were levied against Corner Brook Pulp and Paper, threatening the viability of the company's operations, the Province was successful in its defense of the local newsprint industry. On August 28, 2018, the Department of Commerce dropped all tariffs against Canadian newsprint and subsequently refunded all tariffs paid by producers, including those paid by Corner Brook Pulp and Paper.

Atlantic Growth Strategy

From November 8-13, 2018, the Premier participated in the Atlantic Growth Leadership Committee's multi-sectoral trade and investment mission to China to advance international trade and investment opportunities for Atlantic Canada and promote Atlantic Canadian food, clean growth, education, and tourism sectors. The mission brought together federal Ministers, Premiers, and representation from the business community and post-secondary institutions from across the Atlantic provinces, including 12 businesses from Newfoundland and Labrador. During this mission, the Premier also met with Chinese representatives and industry partners in the oil and gas and mineral sectors to discuss investment and export opportunities for Newfoundland and Labrador.

In March 2019, the Atlantic Provinces and the Federal Government committed to developing a regional Clean Power Roadmap outlining joint action to build a regional clean power network. The Roadmap will identify potentially beneficial Government investments in regional electricity infrastructure including transmission interconnections, next-generation renewable energy technologies, smart grids and energy storage, and

electric vehicle charging networks. The Federal Government has committed \$2 million over two years to support this initiative.

Bill C-69 (Impact Assessment)

The Secretariat, in collaboration with the departments of Municipal Affairs and Environment and Natural Resources, has played an active role in advocating for Provincial interests with respect to Canada's review of environmental and regulatory processes, and in particular Bill C-69, An Act to enact the **Impact Assessment Act** and the Canadian Energy Regulator Act, to amend the Navigation Protection Act and to make consequential amendments to other Acts, which proposes significant changes to the federal environmental assessment process. In February 2019, Premier Ball and the Minister of Natural Resources presented the Province's position on Bill C-69 to the Senate Committee on Energy, the Environment and Natural Resources. The Province's engagement has focused largely on the need for federal environmental assessment legislation to respect the Atlantic Accord principle of joint management in the offshore, as well as highlighting the need to create an internationally competitive regulatory environment that can support the provincial government's efforts to meet ambitious targets for economic growth in the resource sector.

Newfoundland and Labrador-Quebec Cooperation

In April 2018, the Government of Newfoundland and Labrador and the Government of Quebec entered into a Cooperative Agreement concerning the development of the Labrador Trough and the improvement and extension of road infrastructure. As a part of the agreement, both provinces agree to work together to grow their respective economies in these areas. With a view to developing the Labrador Trough, the agreement provides for the following joint works aimed at enhancing collaboration in the following areas of shared interest, including (i) Geotechnical information and land use planning; (ii) Infrastructure for the mining sector; (iii) Labour and skills; (iv) Telecommunications development; and, (v) Enhancements to government processes and business supports. With respect to the improvement and extension of road infrastructure, this agreement provides a framework for the continued improvement of

transportation infrastructure in Newfoundland and Labrador and Quebec, while further developing an economic corridor between the provinces.

The Secretariat, along with the departments of Natural Resources and Transportation and Works, supported implementation of the Cooperative Agreement in 2018-19, and continue to work with Quebec counterparts to advance shared priorities in this area.

Clean Growth and Climate Change

In 2018-19, the Secretariat supported the departments of Municipal Affairs and Environment and Finance in furthering Provincial priorities in the Pan-Canadian Framework on Clean Growth and Climate Change. This work included the development of a made-in-Newfoundland and Labrador approach to carbon pricing based on the principles of maintaining competitiveness for taxation and trade, minimizing the impact on consumers and vulnerable groups, recognizing the considerable cost we are already paying to decarbonize electricity and deliver meaningful reductions in greenhouse gas emissions. This collaboration led to the negotiation of an agreement to provide almost \$90 million in joint federal and provincial funding over the next four years for the Low Carbon Economy Leadership Fund to support provincial climate action programs, including initiatives to reduce greenhouse gas emissions.

Commemoration of Orange Shirt Day

Orange Shirt Day is a commemoration that began in 2013. It reflects upon the entry of six-year-old Phyllis Webstad into the St. Joseph Mission Residential School, outside of Williams Lake, British Columbia, to illustrate the experience of all Indigenous children in residential schools. On September 30, 2018, Premier Ball spoke via Skype with Patrick Ballard and his classmates at Bayview Academy School in St. George's. Patrick submitted the winning design for an orange shirt through a contest organized by the Bay St. George Cultural Revival Centre. Patrick's design was exceptional in that it reflected elements of all Indigenous cultures in Newfoundland and Labrador. Proceeds from the sale of the shirts were used to purchase a traditional Mi'kmaq tipi on the grounds of the school.

Premier Ball also acknowledged a challenge from Abby Carroll of St. George's and pledged to her that every member of the his caucus would wear orange next year on September 30. Premier Ball also called on all members of the House of Assembly, in the spirit of reconciliation and revitalizing our relationship with Indigenous peoples, to join with him in recognizing September 30 as Orange Shirt Day in Newfoundland and Labrador.

National Indigenous Peoples Day

Premier Ball encouraged everyone to take part in events and activities that enhance their appreciation of Indigenous history, heritage and culture. National Indigenous Peoples Day, June 21, recognizes the contributions that Indigenous peoples have made and continue to make to Newfoundland and Labrador. On National Indigenous Peoples Day, Premier Ball spoke at celebrations marking National Indigenous Peoples Day at the First Light St. John's Friendship Centre.

Repatriation of Beothuk Remains

The repatriation of Beothuk remains continued to move forward with the announcement on January 21, 2019 that National Museums Scotland had reached an agreement with the Federal Government and the Canadian Museum of History to arrange the transfer of the remains.

The Secretariat continued to liaise with the Canadian Museum of History, and Indigenous Governments and Organizations on determining next steps for the transfer of the remains to Newfoundland and Labrador when the formal transfer to Canada is completed. The Government, in consultation with Indigenous Governments and Organizations, is committed to an appropriate and respectful process for the transfer of the remains from the Canadian Museum of History to the Province.

The Government acknowledges the partnership with the Federal Government and Indigenous Governments and Organizations on this important and significant

development and commends the advocacy and leadership of Sagamaw Mi'sel Joe on the repatriation of Beothuk remains.

Indigenous Education Advisory Committee

The Secretariat is a member of the Indigenous Education Advisory Committee. This Committee advises the Department of Early Education and Childhood Development on Indigenous content within the provincial curriculum. Also, the Committee is working on a framework document on Indigenous Education for Newfoundland and Labrador.

In addition to the Secretariat, the Committee is comprised of various Indigenous Governments and Organizations, the Department of Early Education and Childhood Development, the Newfoundland and Labrador English School District, the Newfoundland and Labrador Teachers' Association, and Memorial University.

Voisey's Bay Underground Consultation

The Secretariat led Government's Indigenous consultation efforts in 2018 to facilitate the construction of the Voisey's Bay underground mine

On June 11, 2018, the Premier announced the Voisey's Bay underground would proceed with construction starting in the Summer of 2018. The underground mine will extend the operating life of Voisey's Bay by at least 15 years and will result in close to \$2 billion in capital investment by Vale and 16,000 person years of employment during the five-year construction period, peaking at 4,800 jobs in 2020. Once operational, there will be 1,700 jobs at the underground mine and Long Harbour processing plant. The underground mine will also result in 2,135 person years in indirect and induced employment annually; \$370 million per year in labour income; and \$1 billion in economic activity annually that will result in \$69 million per year in provincial tax revenue.

Second Indigenous Roundtable

Following on the success of the first annual Indigenous Leaders' Roundtable held in St. John's in May 2017, the second annual Indigenous Leaders' Roundtable was held in

Corner Brook on June 8, 2018. This Roundtable presents an important opportunity to discuss and advance common interests of the Government and Indigenous Governments and Organizations in Newfoundland and Labrador.

The Premier met with thirteen Indigenous Governments and Organizations at the cabinet room in the Sir Richard Squires Building. The Qalipu First Nation hosted an opening reception the evening before the meeting with traditional foods, dancing, songs, drumming and prayers.

Building upon the progress achieved in the inaugural meeting, the second Roundtable included discussion on next steps toward the repatriation of Beothuk remains, "Towards Recovery: The Mental Health and Addictions Plan for Newfoundland and Labrador", and Government's Cultural Action Plan.

One of the major highlights of the Roundtable was that the Government of Newfoundland and Labrador will partner with Indigenous Governments and Organizations and the University of Saskatchewan to help send Indigenous students from this province to law school. The trilateral partnership will improve access to legal education and create new employment opportunities for members of Indigenous governments and organizations.

The University of Saskatchewan has committed to reserve two seats in the College of Law program annually for Indigenous students from Newfoundland and Labrador. The Government of Newfoundland and Labrador will allocate and fund two articling positions with the Department of Justice and Public Safety for those students upon graduation. Indigenous Governments and Organizations were asked to encourage applicants to apply to law school and fund/identify funding opportunities for educational expenses.

The University of Saskatchewan is dedicated to Indigenous student success, to fostering meaningful relationships with Indigenous communities, and to promoting Indigenous knowledge and scholarship.

The Government of Newfoundland and Labrador is only the second provincial or territorial government to enter into a partnership with the College of Law at the University of Saskatchewan.

National Indigenous Leaders Meeting

The Premier attended the Premiers-National Indigenous Organization (NIO) Leaders meeting held in Pays de la Sagouine, Bouctouche, New Brunswick on July 17-18, 2018.

The agenda for the 2018 meeting focused on discussion in two areas: Economic Partnerships and Indigenous Children in Care. Increasing economic development opportunities for Indigenous people and addressing the overrepresentation of Indigenous children in care continue to be priorities for Provinces/Territories and NIOs.

Report on Performance

Issue #1 - Advancing the Province's Strategic Intergovernmental Priorities

The Secretariat's Intergovernmental Affairs branch supported Government's efforts to ensure that Newfoundland and Labrador's intergovernmental priorities are advanced through productive partnerships with the Federal Government and other sovereign jurisdictions.

In 2018-19, this strategic work included supporting the Premier's advancement of Provincial intergovernmental priorities in meetings of First Ministers' (December 2018), Canada's Premiers (July 2018), the Conference of New England Governors and Eastern Canadian Premiers (August 2018), a bilateral meeting with the Prime Minister (April 2018), and meetings with several federal cabinet ministers.

The Secretariat also supported the Premier's participation in a November 2018 Atlantic Growth Strategy Mission to China, providing analytical support and other protocol assistance in relation to 15 foreign dignitary teleconferences or visits during the reporting year.

The Secretariat advocated to the Federal Government respecting the appropriate level and extent of consultations in the offshore

The Secretariat continued to participate in the Innu Roundtable, an Innu-led initiative that includes Government and the Federal Government, and which is mandated to address community health and healing initiatives for the Innu of Labrador.

The Secretariat provided advice on federal legislation, including the Impact Assessment Act (Bill C-69) which will replace the Canadian Environmental Assessment Act, the federal First Nations, Inuit and Métis Children, Youth and Families Act (Bill C-92), and the federal Indigenous Languages Act (Bill C-91).

The Secretariat participated in and provided advice to several intergovernmental working groups including the Regional Oversight Committee on Oceans Management.

The Secretariat participated in the Minister of Advanced Education, Skills and Labour's Council of Higher Education and the Indigenous Subcommittee advancing Indigenous perspectives and implications.

The Secretariat supported the Federal/Provincial/Territorial meeting of Justice Ministers in St. John's.

Coordinated the Province's response on national Indigenous initiatives including the implementation of the Calls to Action of the federal Truth and Reconciliation Commission, and the participation in the National Inquiry into Missing and Murdered Indigenous Women and Girls and support its implementation of resulting recommendations.

Of the 94 Calls to Action outlined in the Truth and Reconciliation Commission's Report, 30+ Calls to Action were directed at Provinces and Territories.

2019-20 Objective:

By March 31, 2020, the Secretariat will have sustained support of initiatives which promote the enhancement of positive relationships with Indigenous Governments, Organizations, communities and people of the Province.

Indicators:

Strived to complete land claims and self-government agreements with Innu Nation and the Miawpukek First Nation, and continued implementation of the Labrador Inuit Land Claims Agreement.

Monitored the progress of the new Recognition of Indigenous Rights and Self Determination Table announced in July 2018 by the Federal Government and the NunatuKavut Community Council.

Provided advice and support to Government departments and agencies regarding Indigenous interests relating to public policy, programs, and legislation.

Advised Government departments/entities on consultation obligations with Indigenous Governments and Organizations.

Coordinated the annual Indigenous Leaders Roundtable with Indigenous Governments and Organizations to establish priority areas and build stronger relationships with Indigenous people of the province.

Participated in inter-jurisdictional working groups and committees to advance Indigenous interests and advocate

for the Federal Government to discharge its constitutional responsibility to all Indigenous people in the province.

Coordinated the Province's response on national Indigenous initiatives including the implementation of the Calls to Action of the federal Truth and Reconciliation Commission.

Collaborated with provincial departments, the Federal Government, other provinces and territories, and Indigenous Governments and Organizations on the 231 Calls to Justice contained in the final report of the National Inquiry into Missing and Murdered Indigenous Women and Girls.

Worked to repatriate the remains of Demasduit and Nonosabasut from National Museums Scotland.

Continued to work with the Qalipu First Nation to advance issues of importance to their membership.

Opportunities and Challenges

Indigenous Affairs

Indigenous people have unique perspectives that arise from historic, social, cultural, and geographical factors. The Secretariat works with Government departments to develop policies, programs and legislation that better reflect the aspirations of the Indigenous people, and encourage engagement with Indigenous people to ensure their views are heard in the policy process.

Indigenous Affairs will continue to assist Indigenous Governments and Organizations along their paths to self-determination through the negotiation of land claims, self-government, and other agreements. Indigenous Affairs will continue to assess any proposed federal changes to land claims, self-government or other policies.

Also, to advance self-determination, Indigenous Affairs will continue to work with the Federal Government, provincial departments, and Indigenous Governments and Organizations on recently enacted federal legislation on Indigenous children and families, and Indigenous languages.

Indigenous Affairs will maintain collaborative relationships with the Federal Government, other provinces and territories, and Indigenous Governments and Organizations to advance the priorities of Indigenous people in this province. We will continue to engage Indigenous Governments and Organizations in the province by various means such as the Indigenous Leaders Roundtable.

We will continue to work with Government departments and proponents to ensure Government continues to meet its Indigenous Duty to Consult. Government actions or authorizations, that have the potential of adversely affecting asserted or established rights, must be preceded by Indigenous consultation.

We will also continue to assess the implications of the new federal **Impact Assessment Act** as it relates to Indigenous engagement for projects on land and in the offshore.

Indigenous engagement is crucial to environmental assessment, given the overlap between environmental effects and potential adverse impacts on asserted or established Indigenous rights, and this engagement is a major part of the new Act.

Indigenous Affairs will remain ready to assist with the Qalipu First Nation and the Federal Government with the Qalipu enrolment process,

Everyone looks forward to the return of the Beothuk remains of Demasduit and Nonosabasut, at long last, to Newfoundland and Labrador.

We look forward to the findings of the Commission of Inquiry Respecting the Muskrat Falls Project.

Indigenous Affairs will collaborate with provincial departments, the Federal Government, other provinces and territories, and Indigenous Governments and Organizations on the 231 Calls to Justice contained in Reclaiming Power and Place: The Final Report of the National Inquiry into Missing and Murdered Indigenous Women and Girls to bring this violence to an end.

Intergovernmental Affairs

Newfoundland and Labrador continues to deal with a challenging, though improving, fiscal position, an aging population, increased demand for health care services, and the potential impact of climate change. Continued collaboration with the Federal Government is essential to ensuring that Federal-Provincial fiscal arrangements are flexible and adequate to support sustainable public services for Newfoundlanders and Labradorians.

In 2019-20, the Secretariat, in conjunction with the Department of Natural Resources and Department of Finance will partner with the Federal Government to mitigate

electricity rates expected to increase substantially in the coming years. The Secretariat will also continue to work with the Department of Natural Resources, the Federal Government and the other Atlantic Provinces to advance the development of regional electricity transmission corridors that will open up new markets to jurisdictions seeking clean energy sources.

The Secretariat will continue to work with the Department of Fisheries, Land and Resources in partnership with the Federal Government to advance collaborative in Marine Spatial Planning to ensure that future ocean conservation measures give due consideration to growth opportunities for all sectors of the ocean economy, including offshore petroleum development.

In the next fiscal year, the Secretariat will also continue to support the Premier and ministers in achieving the Province's other intergovernmental objectives, including leveraging federal funding, advancing and defending the Provincial Government's trade interests, and promoting trade diversification through access to new markets.
