Assessments of insect development conducted over the week indicate that the following spruce budworm treatment blocks are now ready for treatment with the first application of the biological control product Btk. Subject to weather conditions, treatment will begin in the designated treatment Blocks 211, 212, and 213 east of Gros Morne.

Daily updates will be provided throughout the duration of the program.
