INFORMATION BULLETIN CARBON TAX Carbon Product Tax Rates and Inventory Return

CARBON TAX DUE ON RETAILER INVENTORY AS AT MAY 1, 2022:

Effective 12:01 a.m., May 1, 2022, carbon tax imposed under Part III.1 of the **Revenue Administration Act** will increase as follows:

Carbon product retailers must take and record their existing inventory of carbon products as of 12:01 a.m., May 1, 2022. The *Carbon Products Inventory Return* must be completed and submitted with the additional tax payable resulting from the new carbon tax rates no later than June 20, 2022. Retailers <u>must</u> file a "NIL" return if there is no carbon tax due.

Failure to submit the inventory return by <u>June 20, 2022</u> will result in the imposition of a \$100 late filing penalty and may result in the assessment of a penalty equal to the tax that should have been submitted.
