Variance Explanations 2020-21

- **Revenues** \$631M decrease:
 - Offshore royalties (\$560M decrease)
 - All other revenues (\$71M decrease)
- **Expenses** \$720M increase:
 - Contingency for COVID-19 (\$200M increase)
 - Healthcare/Regional Health Authorities (\$261M increase)
 - Pension, OPEB and debt assumptions (\$127M increase)
 - All other expenses (\$132M increase)

- Plus or minus \$1US in oil price would result in an increase or decrease of approximately \$18.5 million in oil royalties.
- Plus or minus 1 cent in CAD to US exchange rate would result in a decrease or increase of approximately \$8.5 million in royalties.
