**WHOLESALE LICENCE FEES**  
**Under**  
**REVENUE ADMINISTRATION ACT**

- 1 The fees to be paid for a Wholesaler's Licence under the Revenue Administration Act are as follows:
  - (a) the annual fee shall be the aggregate of the following and shall be based on the amount of gasoline products sold in the Province for the purpose of the gasoline tax under Part III of the Revenue Administration Act during the period indicated. (i.e. if applying for 2024, report and base the fee calculation on total sales in Newfoundland and Labrador for the January to October 2023 period, as well as an estimate of sales for November & December 2023, adjusted for the variance of actual to estimated November & December 2022 sales. **Wholesaler to wholesaler sales should be excluded.** :
    - I. For the first 50 million litres, \$0.00035 per litre
    - II. For the next 50 million litres, \$0.00025 per litre
    - III. For the next 100 million litres, \$0.00015 per litre
    - IV. For the next 200 million litres, \$0.00005 per litre
    - V. For any excess over 400 million litres, \$0.00001 per litre
  - (b) for a new licence issued during any year, the amount of gasoline products to be sold during the remainder of the calendar year shall be estimated and the fee shall be determined by applying the calculation described in clause (a) to the amount estimated. Where the wholesaler commenced operations part way through the prior calendar year, the fee shall also be determined based on an estimate of the amount of gasoline products to be sold for the full upcoming calendar year currently being licensed; and
  - (c) In any case the minimum fee shall not be less than \$1,500.
- 2 Where a licence fee paid for any year is initially based on an estimate of gasoline products to be sold, that estimate shall be adjusted with any overpayment being credited to the wholesaler and any underpayment being charged to that wholesaler. For fees payable under clause 1. (b) above, such an adjustment will be required for a wholesaler's first two operating years.
- 3 As per Section 34(1) of the *Revenue Administration Regulations*, you may be required to post a bond as security based upon the amount of tax being collected and reported by your company on a monthly basis, to a maximum of 3 times the amount of tax estimated by the Minister as the amount normally collected by the Collector or other person each month in compliance with the Act.
- 4 For the purposes of item 1, gasoline products sold, exchanged or otherwise transferred by one wholesaler to another licensed wholesaler shall not be included in calculating the volume of gasoline.
- 5 The fees to be paid for a transfer of or an amendment to a wholesaler's license shall be \$100 payable upon filing of the application and shall not be refundable.
- 6 The annual fee is payable by November 15th of each year. For the purposes of this fee "gasoline" includes every liquid or combination of liquids, under whatever name it is known or sold, that is capable of being used for the purpose of generating power in an internal combustion engine whether or not the liquid or combination or a part of it is produced, derived or recovered from petroleum, natural gas, shale or coal and for clarity shall include gasoline, diesel, aviation fuel, vessel fuels, heating fuel, furnace fuel, stove oil, kerosene and propane.
