Overpayments of tax can be used as a credit against the **Gasoline Products Inventory Return** for the period ending December 31, 2022 or a refund can be issued. Confirm below if a refund or a credit is preferred, and if no selection is provided the return will be processed as a credit and applied against tax owing in January 2023.

Please note: As per Section 21 of the **Revenue Administration Act**, in order to receive a refund an overpayment has to be disclosed within 3 years from the date on which the overpayment is made.
