(3) The director shall provide a decision regarding an appeal to the person who submitted the appeal not later than 10 days after receipt of the appeal.

(4) A decision of an appeals officer or the director shall be limited to the requirements of the Act, regulations made under the Act and the policies and procedures of the department and the division with respect to matters to which the Act applies.
