**BACKGROUND**

St. Paul's Development Regulations, 1991 currently permits a range of commercial uses oriented toward vehicular traffic and highway-accessible services in the Highway Commercial (HC) Zone. However, the Regulations presently do not list "General Garage" as either a permitted use or discretionary use, in the HC Zone, even though such uses are typically compatible with highway commercial areas.

**ANALYSIS**

The proposed text amendment to permit "General Garage" as a use within the HC (Highway Commercial) Zone is consistent with the guiding policy framework established in both the St. Paul's Municipal Plan (1987-1997) and the St. Paul's Development Regulations (1991)-Schedule C which formally defines "General Garage" as a land use category. The Municipal Plan articulates a clear vision for economic diversification by encouraging commercial development along major transportation corridors. The HC Zone, by its nature, is strategically located to serve vehicular traffic and provide essential services to highway users allowing general garages, which include repair, maintenance, storage of motor vehicles, and the optional sale of gasoline or diesel oil, supports this intent by enhancing the availability of auto-oriented services in accessible, high-visibility locations. Adding this use to the list of permitted uses in the HC Zone will ensure regulatory clarity, reduce discretionary review burdens, and better align the regulations with the long-standing intent of facilitating highway-commercial services. This amendment therefore represents both a policy-consistent and operationally sound enhancement to the zoning framework.

**PUBLIC CONSULTATION**

Council posted public notice at the Town Office and Post Office and mailed notices to all households in the community on September 8, 2025. The notice informed residents of the proposed amendment and invited written submissions on or before September 26, 2025. As the Town does not operate a community newspaper, website, or Facebook page, mail and physical posting were the only available means of notice. No objections or representations were received by the September 26, 2025, deadline and the public meeting, scheduled for October 2, 2025 was cancelled.

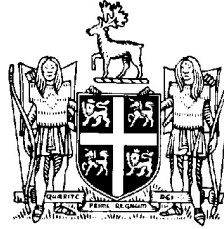

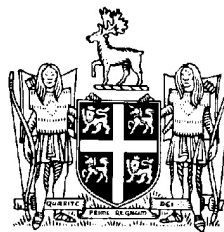
