TO: FEE-FOR-SERVICE NUCLEAR MEDICINE PHYSICIANS AND RADIOLOGISTS PROVIDING MYOCARDIAL PERFUSION IMAGING SERVICES

RE: CHANGES TO MYOCARDIAL PERFUSION IMAGING BILLING AND RETROACTIVE PAYMENTS

In consultation with the Newfoundland and Labrador Medical Association, the Department of Health and Community Services is introducing changes to myocardial perfusion imaging (MPI) fee codes. The **current** Payment Schedule listing for MPI is:

Effective January 6, 2023, fee code 75009 will be retired. In addition, the following changes will also be made to the description and rate for fee code 75008 as highlighted below:

	Myocardial perfusion scintigraphy	
75007	- immediate post stress	68.18
75008	- post-rest	61.42

Please also note:

- 1) only one unit of fee code 75007 is billable.
- 2) fee code 71941 (IV Injections) is not payable with fee code 75018 above (IV Dipyridamole Stress Test) as per Sections 11.11 and 12.5 of the MCP Medical Payment Schedule Preamble.
- 3) SPECT technology has replaced fee code 75009 ("computer data manipulation"). Therefore, fee codes 75210 (SPECT-Single Photon Emission Computerized Tomography) or 75212 (SPECT-with transmission attenuation correction) are billable with MPI fee codes 75007 and 75008. For MPI studies including both a "rest" and "stress" portion, the applicable SPECT code (75210 or 75212) can be billed for a total of two units of SPECT services per patient.

These changes are effective January 6, 2023.

The Department will be reconciling payment for claims submitted for MPI and issuing payment directly to eligible Nuclear Medicine physicians and Radiologists for claims submitted from October 9, 2019 to January 5, 2023. Nuclear Medicine physicians and Radiologists providing these services should continue to submit claims according to current practice until **January 6, 2023**, at which time one unit of 75007, and one unit of 75008 will be available to represent post-stress and post-rest, respectively, in addition to SPECT and other fee codes as applicable and described above.
