**TO: FEE-FOR-SERVICE GENERAL PRACTITIONERS**

**RE: FEE-FOR-SERVICE GENERAL PRACTICE OBSTETRIC BONUS PROGRAM**

There is dedicated funding for a bonus payable to fee-for-service General/Family Practitioners who provide labour and delivery obstetrical services.

## **Eligibility**

Practising **fee-for-service** General Practitioners who provide obstetric services billable as fee code 80004 - *Delivery*, or 80014 - *Attendance at labour* are eligible to receive a bonus payment each year. The most recent one year period for which the bonus is payable is April 1, 2018 to March 31, 2019.

## **Applying for the Bonus**

The 90 day claim submission period for the last date of the one year period will end on July 1, 2019. Eligible General Practitioners should submit an application for the bonus by July 31, 2019. **Calculation of the Bonus**

The bonus amount for an individual physician will be calculated by multiplying the total number of *normal delivery* and *attendance at labour* codes (80004 plus 80014) paid to that physician times \$100 and adding the result to the applicable figure from the following table:

<b>Total Units 80004 + 80014</b>	<b>Bonus Contribution</b>
1-5	\$2,500
6-15	\$5,000
16-30	\$7,500
31 or more	\$10,000

**Example:**

A General Practitioner was paid for 20 deliveries and 4 attendances at labour in the one year period. The bonus payment will be  $(20 + 4) \times \$100$  plus \$7,500 = \$9,900.

**Payment**

The bonus amount will be paid by MCP as a financial adjustment beginning the first pay period in September, 2019. If the payment is delayed for technical reasons, it will be made on the earliest possible upcoming payment date. Applications received after July 15, 2019 will not be approved for payment.
