

CORE STORAGE LIBRARY CONDITIONS OF USE AND WAIVER

The undersigned, hereinafter referred to as the "User" acknowledges that:

- (1) The Department of Natural Resources (the Department) is providing access to the User to the Core Storage Library ("CSL") without warranting that the CSL is fit for the purpose for which the User intends;
- (2) The Department does not warrant, without limitation, the validity of the data, core samples or other information which may be contained within the CSL and accepts no responsibility express or implied for the use of such data or information by the User or third parties;
- (3) The Department takes no responsibility for the condition of the CSL and the surrounding areas including without limitation, stairwells, walkways and parking areas ('related areas");
- (4) it hereby waives all rights and causes of action it may have against the Department as a result of injury or loss to person or property while using the CSL and related areas;
- (5) it accepts responsibility for all loss or damage to the CSL which may be caused by its use of the CSL and related areas and further will reimburse the Department for all costs associated with repairing or rectifying such loss or damage;
- (6) it will indemnify and save harmless the Department from all claims for loss or damage suffered by third parties as a result of its use of the CSL and related areas;
- (7) the Department retains full authority to set the hours of access to the CSL and related areas and that the User must comply with all reasonable demands and directions of the Department while the User is in the CSL and related areas;
- (8) the use of the CSL and related areas is subject to the continued permission of the Department which permission may be revoked arbitrarily and without notice to the User.
