1.0 Overview and Purpose

1.1 The purpose of this procedure is to describe the process for approval and release of Provincial Laboratory Formulary (PLF) communications, and to define the procedure for dissemination of PLF changes to stakeholders.

2.0 Policy Statements

- 2.1 All communications for general distribution are approved by the Provincial Laboratory Formulary Advisory Council (PLFAC). Items requiring communication include additions/deletions and other changes to the PLF and its test entries, or any other items deemed appropriate for broad communication by PLFAC.
- 2.2 All communication submitted for general distribution is organized and reviewed by the PLFAC communications working group prior to final approval by PLFAC. Following approval, these communications may be reviewed again by the PLFAC communications working group, if new changes are made and prior to release. This committee is also responsible for archiving all publicized documents.
- **2.3** The PLF website will serve as the primary repository of PLF documents, communications, and databases.
- 2.4 Dissemination of communications is directed through stakeholder organizations and offices of administrative leads representing stakeholder groups by the PLFAC communications working group, and following authorization by the Director of Clinical Laboratory Services.
- **2.5** PLF information is communicated to stakeholders in the form of: memos and letters of notification, newsletters, and through the PLF website.

3.0 Scope

- **3.1** This policy and procedure applies to all communications including, but not limited to, memos, newsletters, and webpage updates that are developed for informing of stakeholders about PLF related information.
- 3.2 This policy and procedure does not apply to emails, or documents in early preparatory stages that are released to smaller stakeholder teams for comment prior to wider publication.

4.0 Procedure

4.1 All finalized documents that are ready for distribution to stakeholders are first reviewed and approved by PLFAC. The PLFAC at this stage may recommend revisions.

- **4.2** The PLFAC co-chairs will assign a proposed release date to all documents approved for general distribution.
- **4.3** All approved documents with any recommended revisions, will be sent through the office of Director of Clinical Laboratory Services to the PLFAC communications working group for final review and finalizing of the communications, to produce PDF formatted communications materials, and/or to arrange distribution to stakeholders at proposed release dates.
 - 4.3.1 All communications receive final authorization for release by the Director of Clinical Laboratory Services prior to publication.
 - 4.3.2 The PLFAC communications working group will maintain an up to date database of key stakeholders for communications (See example in Appendix A)
- **4.4** The communications working group will communicate PLF item amendments in the following manner:
 - 4.4.1 Inform the Director of Clinical Laboratory Services and PLFAC of any database entry updates where communication to stakeholders is required.
 - 4.4.2 Provide the Director of Clinical Laboratory Services and PLFAC with electronic PDF format copies of communications scheduled for general distribution and/or for upload to the website.
 - 4.4.3 Provide the Director of Clinical Laboratory Services and PLFAC of any recommendations for changes to website content.
 - 4.4.4 Forward electronic PDF copies of communications to stakeholder organizations for further distribution.
 - 4.4.5 Confirm placement of all updated materials on the PLF website.

5.0 Definitions and Acronyms:

- PLFAC Provincial Laboratory Formulary Advisory Council: A provincial committee operating under the Newfoundland and Labrador HCS Laboratory Reform Initiative. The PLFAC assists and advises on laboratory test utilization and development of a PLF.
- **PLF Provincial Laboratory Formulary:** Continuously updated list of laboratory tests that can be ordered by physicians.
- **Stakeholders:** Physicians, Nurse Practitioners and other with test ordering privileges or others representing groups directly impacted.
