 - (i) On Council's Facebook page with repeat postings on May 26, June 9, and June 26.
 - (ii) On Council's website.
 - (iii) On notice boards at the Town Hall, Glenn's Ultramar, and Krista's Clover Farm.

- c) Set the 21st day of June 2021 at 3:00 p.m. at the Town Hall, Bishop's Falls for receipt of written objections and other representations for consideration by the Public Hearing Commissioner.


Under the authority of Section 23 of the *Urban and Rural Planning Act 2000*, the Town Council of Bishop's Falls approves the Bishop's Falls Development Regulations as amended.

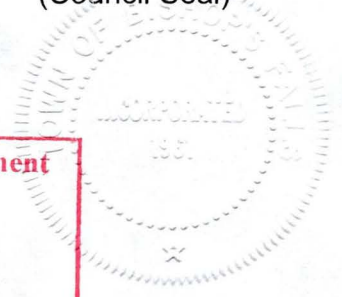

The amendment:

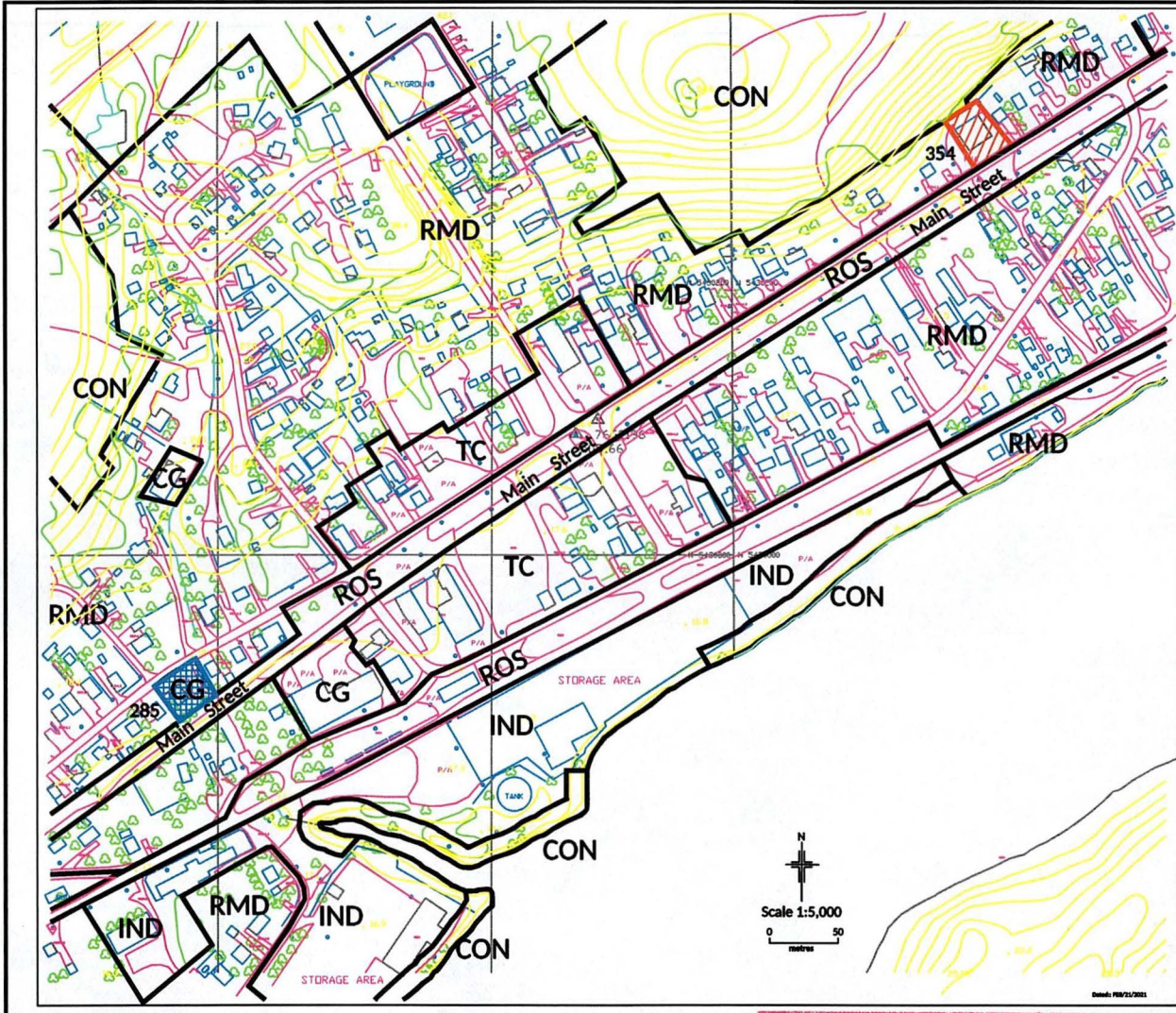
- (1) Rezones the property at 285 Main Street from General Commercial to Residential Medium Density and
