

- c) Held a virtual online public hearing to consider objections and submissions between July 21 and August 20, 2021.



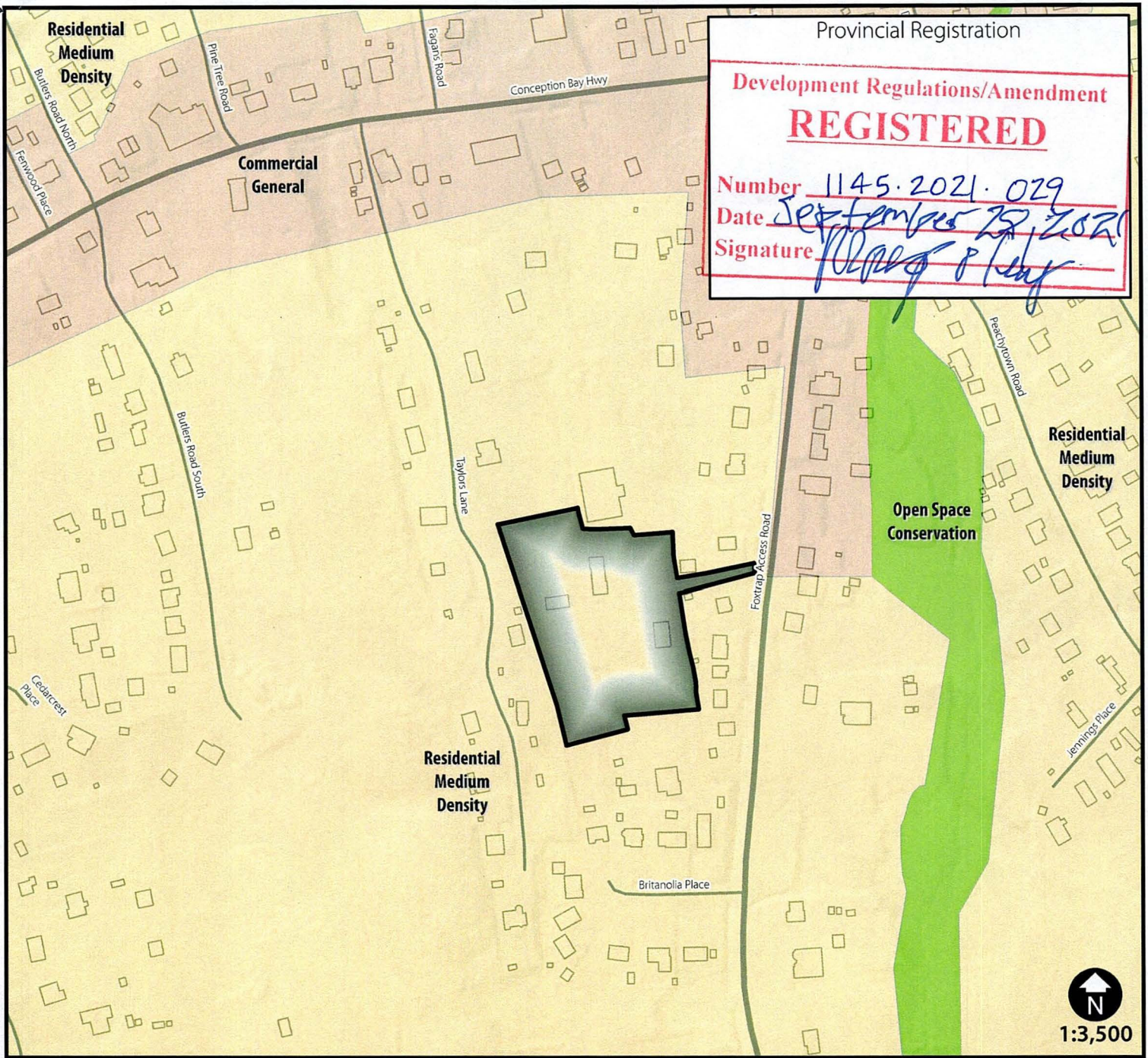
