TAKE NOTICE that the TOWN OF CONCEPTION BAY SOUTH MUNICIPAL PLAN AMENDMENT No. 28, 2023 and DEVELOPMENT REGULATIONS AMENDMENT NO. 47, 2023, adopted by the Town Council on June 13th, 2023, has been registered by the Minister of Municipal and Provincial Affairs.

In general terms, CONCEPTION BAY SOUTH MUNICIPAL PLAN AMENDMENT NO. 28, 2023 and DEVELOPMENT REGULATIONS AMENDMENT NO. 47, 2023 re-designates and re-zones land at 118 red bridge Road from the "Open Space Recreation" to the "Residential Medium Density" designation and zone.

CONCEPTION BAY SOUTH MUNICIPAL PLAN AMENDMENT NO. 28, 2023 and DEVELOPMENT REGULATIONS AMENDMENT NO. 47, 2023 come into legal effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*.
