






- a) Adopted the Municipal Plan Amendment MP18-05 on the 28<sup>th</sup> day of May, 2018;
- b) Gave notice of the adoption of the Municipal Plan Amendment MP18-05 by advertisement inserted on the 30<sup>th</sup> day of May, 2018 and the 6<sup>th</sup> day of June, 2018 in the Western Star newspaper;
- c) Set the 13<sup>th</sup> day of June, 2018 at 7:00 p.m. at the City Hall, Corner Brook, for the holding of a public hearing to consider objections and submissions.

### 1. Type

Municipal Plan Amendment No. MP18-05 to the City of Corner Brook’s Integrated Municipal Sustainability Plan 2012 (henceforth the “Amendment”) is a text amendment.

### 2. Purpose

The purpose of this Amendment is to add the “outdoor assembly” use class as discretionary (i.e. may be permitted by Council) under the “General and Light Industrial Areas – Uses” policy subsection (4.5.3-17; see attached “Proposed IMSP Policy”). This policy change will allow Council to add the “outdoor assembly” use as a discretionary use under the “General Industrial (GI)” use zone table of the 2012 Development Regulations (see associated Development Regulations Amendment No. DR18-05).

### 3. Public Consultation

In accordance with section 14 of the Act, City staff conducted public consultation by advertising the Amendment in a locally circulated newspaper (Western Star) on March 3 and 10, 2018. City staff provided the public with opportunity to inspect and provide comments on the Amendment.

#### **4. Provincial Release**

In accordance with section 15 of the Act, City staff forwarded the Amendment to the provincial Department of Municipal Affairs and Environment for review. Where no agency or departmental interests were identified, the Amendment was released from the Local Governance and Planning Division on May 17, 2018.

#### **5. Adoption by Council and Public Hearing**

In accordance with section 16 of the Act, Council adopted the Amendment on May 28, 2018. In accordance with section 17 of the Act, notice of adoption and tentative public hearing date (June 13, 2018) was published in a locally circulated newspaper (Western Star) on May 30 and June 6, 2018.

Where no objections were received two (2) days before the tentative public hearing date, Council cancelled the public hearing in accordance with section 20 and subsection 21(1) of the Act.

#### **6. Approval by Council**

In accordance with section 23 of the Act, Council approved the Amendment (as adopted) on June 11, 2018.

#### **7. Amendment Statement**

The City of Corner Brook's Integrated Municipal Sustainability Plan 2012 is amended by adding the "outdoor assembly" use class as discretionary under the "General and Light Industrial Areas – Uses" policy subsection (4.5.3-17) as per the attached "Proposed IMSP Policy" amending document.
