

Amendment No. 2, 2021 to the South River Development Regulations is enacted to comply with Amendment No. 2, 2021 to the South River Municipal Plan.

The amendment rezones approximately 0.4 hectares of land located at 45-49 Conception Bay Highway from Commercial to Mixed Development.
