BACKGROUND

The Town of Lewisporte proposes to amend its Development Regulations. The Town has received a proposal to develop a single lot on vacant land located east of Maple Crescent. The land has sufficient area with frontage on Maple Crescent. The residential lot shall conform to all standards of the Residential Medium Density Land Use Zone Table.

The purpose of this Amendment is to designate an area of land east of Maple Crescent from **Open Space Recreation (OSR)** to **Residential Medium Density (RMD)**.


PUBLIC CONSULATION

During the preparation of this amendment, Council undertook the following initiative so that individuals and groups could provide input to the proposed Municipal Plan Amendment. The Town Council of Lewisporte published a notice in *The Pilot* newspaper on September 13, 2017, advertising the proposed amendment to consider comments, objections and representations from the public. The Town Council also placed the proposed amendment on display at the Town Council Office from September 13 to September 20, 2017, for residents to view and to provide any comments or concerns in writing to the Council concerning the proposed amendment. No verbal or written comments were received.

AMENDMENT No. 25, 2017

The Town of Lewisporte Development Regulations is amended by:

 A) Changing an area of land from "Open Space Recreation (OSR)" to "Residential Medium Density (RMD)" as shown on the attached copy of the Town of Lewisporte Land Use Zone Map.


