## TOWN OF LEWISPORTE DEVELOPMENT REGULATIONS AMENDMENT No. 27, 2018

#### BACKGROUND

The Town of Lewisporte proposes to amend its Development Regulations. The Town has received a proposal to expand the Lewisporte Guest Home located at the end of Pleasant Street. Land for the proposed expansion is presently zoned as Residential Medium Density.

The recent Development Regulations Amendment No. 26, 2017, added special care intuitional uses as a discretionary use to Residential Medium Density Land Use Zone Table. However, a condition with that Amendment limited special care institutional uses as homes for the aged and limited their location to Masonic Terrace.

The purpose of this Amendment is to re-zone land for the expansion the Lewisporte Guest Home from Residential Medium Density (RMD) to Residential Senior Citizens (RSC).


### **PUBLIC CONSULATION**

During the preparation of this amendment, Council undertook the following initiative so that individuals and groups could provide input to the proposed Development Regulations Amendment. The Town Council of Lewisporte published a notice in *The Central Voice* newspaper on August 29, 2018, advertising the proposed amendment to consider comments, objections and representations from the public. The Town Council also placed the proposed amendment on display at the Town Council Office from August 29 to September 5, 2018, for residents to view and to provide any comments or concerns in writing to the Council concerning the proposed amendment. Five letters of opposition were received and considered by Council at its regular meeting of September 11, 2018.

### **AMENDMENT No. 27, 2018**

The Town of Lewisporte Development Regulations is amended by:

A) Changing an area of land from Residential Medium Density (RMD) to Residential Senior Citizens (RSC) as shown on the attached copy of the Town of Lewisporte Land Use Zone Map.
