

TOWN OF LEWISPORTE MUNICIPAL PLAN AMENDMENT No. 2, 2009

BACKGROUND

The Town of Lewisporte proposes to amend its Municipal Plan. The Town has received a proposal to develop duplex housing off Route 340. The area is presently designated as Residential on land directly fronting on Route 340 and Rural on land to the rear. The Residential designation allows for single dwellings on unserviced lots approved by the Government Service Centre. The proposal is for land to the rear for double or duplex housing. The proposed amendment will add double dwellings as a permitted land use in the Residential designation on land along Route 340.

The proposed amendment will also re-designate land from Rural to Residential on land to the rear of Route 340, to accommodate the proposed development.

PUBLIC CONSULTATION

During the preparation of this amendment, Council undertook the following initiatives so that individuals and groups could provide input to the proposed Municipal Plan amendment. The Town Council of Lewisporte published a notice in *The Pilot* newspaper on July 29, 2009, advertising the development proposal seeking comments or representations from the public. The Town placed the proposal on display at the Town Office. No verbal or written comments were received during the time period.

AMENDMENT No. 2, 2009

The Town of Lewisporte Municipal Plan is amended by:


A) Deleting, with strikeout, and adding the following text to Section 3.2.2.3

3.2.2.3 Residential - Rural

Lands on the South Side of Lewisporte, Route 340, have been designated Residential Rural to provide residential opportunities in a rural setting.

Policies:

- Single *and double* detached dwellings shall be the only residential use permitted within this designation.
- **B)** Changing an area of land from "Rural" to "Residential" as shown on the attached copy of the Town of Lewisporte Municipal Plan Future Land Use Map.
