### TOWN OF LEWISPORTE MUNICIPAL PLAN AMENDMENT No. 11, 2013

### **BACKGROUND**

The Town of Lewisporte proposes to amend its Municipal Plan. Route 340, Road to the Isles, has seen recent commercial expansion in the past number of years. This expansion is mostly contained on both sides of Route 340 from the intersection with Main Street running to the Southwest Brook Bridge.

Recently, it was discovered that the last commercial building on the north side of Route 340 is in the Open Space designation. To correct this error, this amendment proposed to re-designate a small area of land with an existing commercial building to Commercial.

The Lewisporte Future Land Use Map has this area designated as Open Space. A land survey indicates that there is sufficient land to expand the Commercial designation to the east to accommodate the existing building, while maintaining a 15 metre shoreline reservation from the waters of Lewisporte Harbour.


#### **PUBLIC CONSULATION**

During the preparation of this amendment, Council undertook the following initiative so that individuals and groups could provide input to the proposed Municipal Plan Amendment. The Town Council of Lewisporte published a notice in *The Pilot* newspaper on September 5, 2013, advertising the proposed amendment to consider comments, objections and representations from the public. The Town Council also placed the proposed amendment on display at the Town Council Office from September 5 to September 12, 2013, for residents to view and to provide any comments or concerns in writing to the Council concerning the proposed amendment. No verbal or written comments were received.

### **AMENDMENT No. 11, 2013**

The Town of Lewisporte Municipal Plan is amended by:

A) Changing an area of land from "Open Space" to "Commercial", as shown on the attached copy of the Town of Lewisporte Future Land Use Map.
