#### **DEVELOPMENT REGULATIONS AMENDMENT No. 2, 2018**

#### BACKGROUND

The Town of Hughes Brook proposes to adopt the following amendment to its Development Regulations. The purpose of the amendment is to implement the Hughes Brook Municipal Plan Amendment No. 2, 2018, which is being adopted to permit unserviced residential lots on a former farm site in the north of the town.

Council has also received a proposal for a road connection across the brook lying to the north of the former farm site.

In order to accommodate these changes, Council proposes to amend the Development Regulations as follows:

- (1) Change the Land Use Zone of the former farm site from "Rural" to "Residential."
- (2) Change the Land Use Zone along a 15-metre strip along the brook that abuts the former farm site from "Rural" to "Conservation."
- (3) Add "transportation" as a discretionary use in the Conservation zone.


