# TOWN OF BAY BULLS DEVELOPMENT REGULATIONS AMENDMENT No. 1, 2016

#### **BACKGROUND**

The Town of Bay Bulls proposes to amend its Development Regulations. The Town has received a comprehensive proposal for an unserviced Residential Subdivision to be located east of the Southern Shore Highway, Route 10. The subdivision design meets the requirements of the Residential Land Use Zone Table which requires a minimum frontage of 30 m and a minimum lot area of 1860 m². The subdivision design has future access points to the north, east and west to allow for future development of adjacent lands.

The area is presently zoned as Residential Subdivision Area (RSA). This Amendment proposes to re-zone land required for the Residential Subdivision from Residential Subdivision Area (RSA) to Residential (Res).

#### **PUBLIC CONSULTATION**

During the preparation of this amendment, Council undertook the following initiatives so that individuals and groups could provide input to the proposed Development Regulations amendment. The Town Council of Bay Bulls published a notice in *The Telegram* newspaper on December 5, 2016, advertising the development proposal seeking comments or representations from the public. The Town Council placed the proposed amendment on display at the Town Office from December 7, to December 11, 2016, for residents to view and to provide any comments or concerns in writing to the Council concerning the proposed amendment. One letter of objection was received during the time period and resolved to the satisfaction of the objector.


#### ST. JOHN'S URBAN REGION REGIONAL PLAN

The St. John's Urban Region Regional Plan Map has designated the area covered by the proposed Amendment designated as Urban Development. The proposed Development Regulations Amendment conforms to the St. John's Urban Region Regional Plan and it is concluded that a Regional Plan Amendment is not required.

## **DEVELOPMENT REGULATIONS AMENDMENT No. 1, 2016**

The Town of Bay Bulls Development Regulations are amended by:

A) Changing an area of land from "Residential Subdivision Area" to "Residential", as shown on the attached copy of the Town of Bay Bulls Land Use Zone Map.


