



1. Rezone lands currently zoned Environmental Protection to accommodate future commercial development.

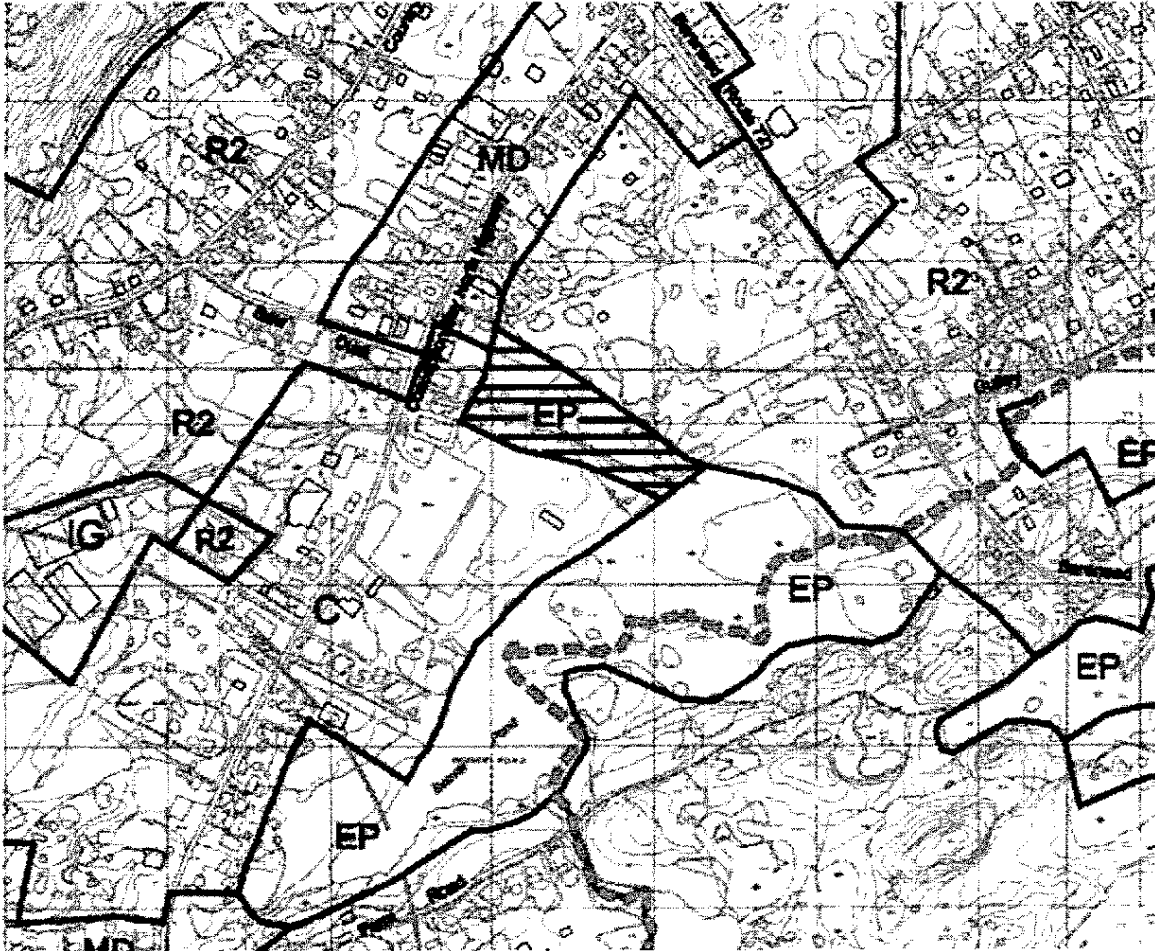
Amendment No. 2
