
Under the authority of section 16, section 17 and section 18 of the *Urban and Rural Planning Act 2000*, the Town Council of Bishop's Falls



**BACKGROUND**

The Town of Bishop's Falls proposes to adopt the following amendment to its Municipal Plan to accommodate the proposed development of multi-use self-storage units on the site. The amendment will change the current Land Use Designation of the site from Residential to Industrial.

The site is located on the east side of the Botwood Highway. The area of the proposed amendment is approximately 36,000 square metres (3.6 hectares).

**PUBLIC CONSULTATION**

Notice of proposed Amendment No. 3 was provided in the following ways:

- (1) Advertisement in the June 15, 2017 edition of the Advertiser newspaper.
- (2) The attached notice was placed on the Town's website on June 9, 2017.
- (3) The attached notice was posted at four locations on June 9, 2017: (1) Town Office, (2) Bank of Montreal ATM, (3) Shopper's Drug Mart, and (4) Krista's Clover Farm.

A period up to June 26 was provided for the submission of comments. No comments were received as of the deadline.

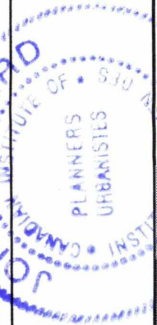

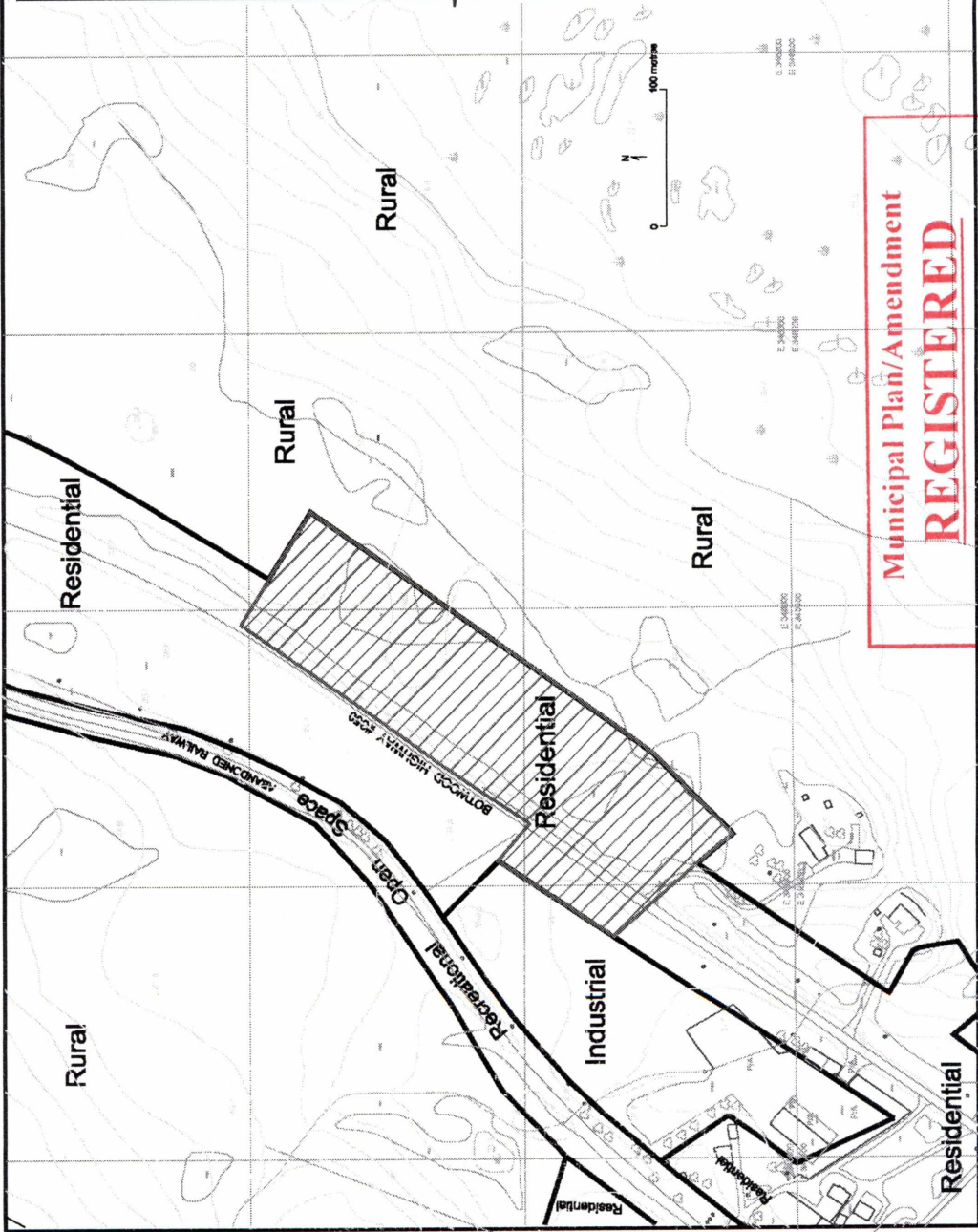
