#### TOWN OF CARMANVILLE MUNICIPAL PLAN AMENDMENT No. 1, 2016

The Town of Carmanville wishes to allow a proposed tourism and commercial recreational development in the northwestern portion of its Planning Area. The proposed site is currently designated Rural in the Municipal Plan and Development Regulations. Council proposes to amend the land in question from Rural to a new designation referred to "Tourism Commercial." This will give Council the authority to allow tourism and recreational uses such as amusement parks, campgrounds, tourist cottages, and associated retail and catering uses.

#### PUBLIC CONSULTATION

Council issued a public notice of the proposed amendment (see attached) on May 11, 2016. It was posted on the Town's website (www.townofcarmanville.ca), on Carmanville Connect (Facebook), and in the following venues around town: Municipal Building, G & M Services, Canada Post Office, Carmanville ValuGrocer, and Talk's Home Hardware. The notice asked for written or verbal comments by Friday, May 20.

No objections to the proposed amendment were received, however, two residents informed the Town Manager that relatives of theirs own property within the affected area. They were advised that all of the area is listed as Crown land and that they should contact the Crown Lands agency.

## MUNICIPAL PLAN AMENDMENT No. 1, 2015

Amendment No. 1 to the Carmanville Municipal Plan includes the following changes:

#### ADD the following section to Section 3.3 - Urban Development: 1.

#### Tourism Commercial Designation

An area of land in the vicinity of Noggin Cove Head, as shown on the Carmanville Future Land Use Maps, is designated Tourism Commercial to allow for a mix of tourist related commercial developments.


#### **Tourism Commercial Policies**

- The Tourism Commercial designation is established to encourage the development of this area with a mix of commercial and recreational activities to build on and enhance the 3.3.16 tourism potential of Carmanville and region.
- Permitted land uses in the Tourism Commercial designation include conservation and open space, which are complementary to the general intent of the designation. All other proposed 3.3.17 uses will be considered on a discretionary basis.

Uses that may be permitted at Council's discretion include amusement uses, campgrounds, catering, commercial accommodations, drinking establishments, entertainment uses, general assembly uses, indoor assembly uses, outdoor assembly uses, outdoor markets, recreational open space, take-out food services, and tourist cottage establishments.

2. AMEND Carmanville Future Land Use Maps A and B as shown on the attached map. The amendment redesignates approximately twenty (20) hectares of land from "Rural" to "Tourism Commercial."
