### **BACKGROUND TO AMENDMENT NO. 4**

The Community of Forteau has adopted the following amendment to its Land Use Zoning, Subdivision and Advertisement Regulations. The purpose of the amendment is to change the zoning of a site on the highway to allow for the development of a senior citizen's home. A condition limiting the purpose of residential development in this zone is also added.

## AMENDMENT NO. 4

The community of Forteau Land Use Zoning, Subdivision and Advertisement Regulations are amended as follows:

- 1. The map titled Zoning Plan, Map No. 1 is amended by changing the zoning of a site from Commercial General to Institutional Medical as shown on the attached copy of the map.
- 2. Schedule C, the Institutions Medical use zone table is amended by adding the following new Condition 3 as follows:

## "3. Residential Dwelling Uses

The uses classes in the Residential Dwelling Uses Division shall be limited to senior citizens housing projects and housing developed as a part of a Medical Treatment and Special Care Use."
