## TOWN OF SUMMERFORD MUNICIPAL PLAN AMENDMENT No. 4, 2008

### 1.0 – Background

The Town of Summerford Municipal Plan designates land at the southern entrance to the community on either side of Route 340 for Commercial purposes but this expectation has not been realized. However the town continues to experience demand for residential land in this area. In response to this demand Council now wishes to amend its Municipal Plan by redesignating this land from the "Commercial" land use designation to the "Residential" land use designation. This will enable the development of this property consistent with the adjoining lands to the north.

## 2.0 – Public Consultation

Council gave notice of its proposal to amend its Municipal Plan as noted above by insertion in The Pilot dated the 9<sup>th</sup> day of July, 2008 of an advertisement asking for comment, but received no input.

#### 3.0 – Amendment No.4 - 2008

The Town of Summerford Municipal Plan, Future Land Use Map B is amended by redesignating the lands on either side of Route 340 at the southern entrance to the community from the "Commercial" land use designation to the "Residential" land use designation, shown more precisely on the attached map.
