The Town Council of Wabana wishes to amend its Development Regulations to implement Municipal Plan Amendment No. 1 2002.



As this amendment to the Wabana Development Regulations is implementing Municipal Plan Amendment No. 1, 2002, the same consultation process was undertaken.


AMENDMENT NO. 1, 2002
