ACCESS TO INFORMATION AND PROTECTION OF PRIVACY ACT, 2015

VARIATION OF DEADLINE NOTICE

NOTICE IS HEREBY GIVEN that in accordance with the authority under section 3 of the *Temporary Variation of Statutory Deadlines Act*, the Minister of Justice and Public Safety, on the advice of the Attorney General, hereby varies the following timeline set out in the *Access to Information and Protection of Privacy Act*, 2015:

Section 117 The requirement to refer the Access to Information and Protection of Privacy Act, 2015 or part of this Act to a committee for the purpose of undertaking a comprehensive review "not more than 5 years after the coming into force of this Act" is varied to "not later than December 1, 2020".
