Team NL is currently looking to fill Chef Team roles for the 2025 Canada Summer Games taking place in St. John's from August 8-24, 2025.

The Chef team is comprised of a Chef de Mission along with two Assistant Chef de Missions. The Chef team works closely with Sport NL and its Games Coordinator in preparing Team NL participation at the Games. Below is a description of each position:

Chef de Mission

The Chef de Mission is the team leader for the provincial contingent and, in consultation with Canada Games Council, the Host Society and Sport Newfoundland and Labrador coordinates the overall participation of Team NL participation in the Canada Games. The Chef ensures that all requirements are complete in a manner, which upholds the spirit and philosophy of the Canada Games movement.

Assistant Chef(s) de Mission (Two positions)

The two Assistant Chef de Missions are second-in-command for Team NL and in the absence of the Chef, acts as its designate. In addition to providing general support to the Chef, the Assistant Chef(s) usually hold primary responsibility for specified components of operational requirements of the provincial contingent.
