Re: Reminder - Call for Applications - 2024-2025 Municipal Capital Work

Date: September 22, 2023

The Department of Transportation and Infrastructure would like to remind eligible funding recipients to submit Municipal Capital Works (MCW) applications for its 2024-2025 Municipal Capital Works Program **by the September 29, 2023, submission deadline**. The application period opened on August 7, 2023, and was announced via a circular, available at <https://www.gov.nl.ca/ti/mi/circulars/#c2023>.

There are some important additional reminders, outlined in the August 7 circular, that potential applicants should consider:

- This intake is for the MCW provincial funding program only.
- Applications that suitably address existing Boil Water Advisories, compliance with Federal Wastewater Systems Effluent Regulations, or impacts of climate change are of particular interest.
- There is a revised Project Construction Estimate template provided online, which is required to be used for infrastructure project applications.

Applicants should check the website periodically for any updates. Should you not have internet access, please contact the local Regional Office for a printed copy of the applicable forms and guide.

All submission requirements outlined in the Application Guide should be provided by the deadline as late or incomplete applications may not be considered. Applicants should consider submitting their applications as early as possible, as the online application submission website (MSIS) experiences a significant amount of traffic leading up to final days before the deadline.


