OVERVIEW

On February 27, 2006, the Government of Newfoundland and Labrador announced the formation of the Minister's Advisory Committee on Labrador Transportation. This Committee consists of key stakeholders representing the needs of people and businesses across Labrador. The committee provides a two-way forum to share views on policy, programs and services, as well as, represents a common understanding of the transportation needs of people and businesses throughout Labrador.

Chaired by the Minister of Transportation and Works, the Advisory Committee consists of up to ten members and must ensure representation from across Labrador. Committee members are appointed for a two-year term, renewable at the Minister's discretion, and meetings take place when deemed necessary by the Minister.

MANDATE

The Minister's Advisory Committee on Labrador Transportation is a volunteer committee of key stakeholders whose mandate, as outlined in their Terms of Reference, is:

1. To provide a two-way forum to share views and provide advice on policy, programs and services, both existing and proposed, for transportation matters in Labrador.
2. To develop a common understanding of the transportation needs of people and businesses throughout Labrador.

VALUES

The Minister's Advisory Committee is instrumental in advising the Provincial Government as it moves forward to address the challenges and demands related to transportation in Labrador. This Committee is chaired by the Minister of Transportation and Works, and as such, has adopted the values of the Department, where applicable.

The values of the Department of Transportation and Works are as follows:

MISSION

The Department of Transportation and Works will have improved transportation and building infrastructure and service delivery that support the social and economic needs of Newfoundland and Labrador by 2017.

The mission statement identifies the priority focus of the Minister of the Department of Transportation and Works. By conveying the transportation needs of Labradorians, the Committee assists Government in improving and aligning transportation services to meet the future economic and social needs of the Province. ACTIVITIES

The Minister's Advisory Committee exists exclusively as an advisory body to Government and therefore has not developed goals but rather a single objective that will be reported on annually throughout the duration of its 2014-17 Activity Plan.

The Committee serves as a two-way forum to share views and provide advice on policies, programs and services. Through open and candid discussions, the Committee represents a common understanding of transportation needs and serves as a tool for greater informed decision-making regarding transportation in Labrador.

By March 31, 2015, the Minister's Advisory Committee on Labrador Transportation will have provided advice to the Minister pertaining to transportation in Labrador.

CONCLUDING REMARKS

Labrador is experiencing exciting commercial growth. To support these new opportunities the Provincial Government is supporting significant infrastructure development in the region. Great progress continues to be made in paving the Trans Labrador Highway, with investments totaling more than \$500 million over multiple years, we have developed and paved 463 kilometres of highway connecting communities and creating new opportunities for residents and businesses. Budget 2014 allocated another \$83.6 million for work to continue. The Provincial Government continues to work towards securing a more efficient and long-term solution for ferry-dependent communities in Labrador. A Request for Proposals was issued in December 2013 to secure a single contractor to provide a comprehensive passenger, vehicle, and freight service to Labrador, over a 15-year term, commencing in 2016. The input from Committee members on these and other transportation initiatives plays a key role in the success of the Minister's Advisory Committee in achieving its mandate.

On behalf of the Committee, I would like to take this opportunity to reaffirm our commitment to fulfilling our mandate for the betterment of transportation polices and infrastructure in Labrador.
